

B. Pharm. (Undergraduate Course) Intake: 100

Eligibility F. Y. B. Pharm.:

The candidate should be an Indian National; Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 50% marks (at least 45% marks in case of candidates of Backward class categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together obtained non zero score in CET or non zero positive score in NEET for All India Candidature.

Eligibility Direct Second Year B. Pharm. (Lateral Entry)

Passed Diploma Course in Pharmacy with at least 45 % marks(at least 40 % marks in case of candidates of Backward class categories and Persons with disability belonging to Maharashtra State only) from an All India Council for Technical Education or Pharmacy Council of India or Central or State Government approved Institution or its equivalent.

Eligibility D. Pharm. (Post HSC Diploma Course) Intake: 60

The candidate should be an Indian National; Passed the HSC Science with Physics and Chemistry as compulsory subjects along with one of the subject Mathematics or Biology.

Note: Other than Maharashtra State Candidates shall be eligible for Institution quota only.

Eligibility M. Pharm.:

Passed Bachelor's Degree in Pharmacy from any All India Council for Technical Education or Pharmacy Council of India or Central or State; Government approved institution, with at least 55% marks (at least 50% marks in case of Backward Class category and Persons with Disability Candidates belonging to Maharashtra State only); Obtained score in Graduates Pharmacy Aptitude Test (GPAT) conducted by All India Council for Technical Education; For sponsored candidates, minimum of two years of full time work experience in a registered firm/ company/industry/ educational and/ or research institute/ any Government Department or Government Autonomous Organization in the relevant field in which admission is being sought.

Admission process: Admission Process is briefly explained as under.

- 1. The rules and regulations for admissions are as per regulating authority declared time to time. These regulations are applicable to candidates.
- 2. MHT-CET examination is conducted by admission authority (DTE, Mumbai)
- 3. Declaration of the result of MHT-CET/NEET
- 4. Document verification, filling of online application form for centralized admission to Pharmacy i.e. CAP and confirmation at the application form receipt centers(ARCs) by eligible MHT-CET qualified candidates.
- 5. Merit list of candidates who have confirmed the online application form for centralize admission to Pharmacy is displayed on the websit or admission regulating authority, Mumbai.
- 6. Fill in and confirmation of the online option form(s) for CAP Round(s) I/II/III by candidate eligible to participate in these CAP rounds on the website
- 7. Allotment(s) of respective CAP round(s) I/II/III are display on the website.
- 8. Reporting to respective institutes as per allotment of CAP Round(s) I/II/III.

Note:-A notification giving details such as schedule, procedure of centralized Admission is displayed on the website and published in leading newspapers.

Guidelines For Institute Level Admission

All admissions are carried out in fully fair and transparent manner and are merit based.

The Principal of the college invites applications for the seats available by giving publicity at least in two news papers. Vacancies are also displayed on the notice board and website of the college.

Detailed schedule of the admission process is also displayed on notice board and website.

Aspiring candidates fulfilling the eligibility criteria apply directly to the Principal. The admissions are made in a transparent manner and strictly as per the merit of the candidates who have applied to the college.

Information brochure/prospectus of the college which specifies rules of admission are published well before the commencement of the process of admission for seats to be filled at the college level. All the information in the brochure is also displayed on the college website.

Note:-A notification giving details such as schedule, procedure of centralized Admission is displayed on the website and published in leading newspapers. The procedure may change as per the rules and regulations of Govt. of Maharashtra.

Fee Structure: Approved fee Structure by Fee Regulating Authority is Rs. 94000/- (For B. Pharm.) & 122500/- (For M. Pharm.) per year for academic year 2019 - 2020. For D. Pharm. course the Ad-hoc fee declared by Fee Regulating Authority is applicable.

Rules for Attendance: To appear for university and internal exams 80 % of attendance is compulsory.

Syllabus: The course structure and syllabus for B. Pharm. and M. Pharm. course is as per Pharmacy council of India, New Delhi. and Savitribai Phule Pune University, Pune. The D. Pharm. syllabus is as per MSBTE, Mumbai and Pharmacy council of India, New Delhi.



PLACEMENT DETAILS LAST FOUR YEARS















1. RULES REGARDING DISCIPLINE:

- a. Creating nuisance in the campus is liable for disciplinary action.
- b. The students must kee his/her mobile phone switched off during lecture hours and lab sessions. Violation of this rule will lead to confiscation of mobile by the concerned teacher. Same will be handed over only to parents/guardians in person.
- c. Ragging is strictly prohibited in the campus [Maharashtra Prohibition of Ragging Act 1999]
- d. Students should take care of their belongings. College authority will not be responsible for any loss or theft.
- e. Smoking or chewing gum, gutka, pan in the premises is strictly prohibited.

2. RULES REGARDING ATTENDANCE:

- a. The college expects 100% attendance for theory and practical session. Some relaxation is possible to the extent of 10% on valid reason and prior permission of the principal.
- b. In no case the attendance should be less than 80% separately for theory and practicals otherwise he/she may be detained from appearing university exams.

3. RULES REGARDING UNIFORM

- a. Wearing of l-Card everyday and uniform everyday except Thursday is compulsory. The student must also wear uniform during university examination and various committee visits.
- b. While representing our college during various events students must wear the college uniform.
- c. College uniform should be clean and ironed properly. Students who are soapily dressed or wearing dirty clothes are liable to send home.
- d. Uniform: black trousers and white shirts.

4. RULES REGARDING CARE OF COLLEGE PROPERTY:

- a. Students should treat all college property with care.
- b. Students are forbidden to write or scribble on the wall and furniture, dirty the classrooms or damage any material.
- c. Parents/guardian will have to compensate for willful damage done to college property.

5. RULES REGARDING LEAVE:

- a. Students should take prior permission of leave from respective class teacher before proceeding on leave. (Refer to leave format given in diary).
- b. In case of emergency, parents can contact respective class teacher on given phone number.
- c. If the student takes sick leave for more than 3 days, he/she must produce a medical certificate.
- d. No student suffering from any contagious or infectious disease shall be permitted to attend classes.

6. RULES REGARDING LIBRARY FACILITIES:

- a. Silence should be observed in the library at all times.
- b. Students should not bring any book of their own into the library except their notebooks and pen or pencil.
- c. Books should be returned on or before the due date indicated on them without fail. Delay in doing so will result in a fine of Rs 5/-per dayper book.
- d. The librarian has the right to recall book from students or staff at anytime, even before due date indicated on book.
- e. Books can be renewed for a period of one week, provided if the book is not in great demand.

- f. Before leaving the library, books to be borrowed must be carefully examined by the student. He/she should report any damage to the book to the librarian immediately. A fine will be levied on the books that are found damaged on return.
- g. If the book is lost, it must be replaced at once or duly compensated for.
- h. Reference books such as the dictionary and encyclopedia cannot be borrowed.
- I. No book, magazine or newspaper shall be taken out of the library without the permission of librarian.

7. RULES REGARDING ADMINISTRATIVE WORK

- a. Office and accounts section timing for students-
 - Timing: 10.30 a.m. to 3.00 p.m. Lunch Break: 1.30 p.m. to 2.00 p.m. Fee Receipt Time: 10.30 a.m. to 2.00 p.m.
- b. Following are the facilities available at Students section:
- i. Stamp and sign for PMT bus pass and railway concession.
- ii. Bonafide certificate
- iii. Regarding education loan
- iv. Scholarships, freeships, earn and learn scheme, etc.
- c. Certificates will be issued on the next working day from the receipt of application
- d. Students must read all the notices carefully that are displayed on the Office notice board, especially for due dates so as to avoid further inconvenience.

8. RULES REGARDING CONDUCT IN LABORATORY:

- a. Silence should be observed while doing practical work in the laboratory.
- b. The instruction given by the teacher and laboratory assistant must be followed.
- c. Students will be responsible for any breakage or loss of the apparatus used in the experiment. Any breakage or loss should be reported to the teacher in-charge.
- d. Students should bring proper record books and observation note books.
- e. Students should strictly adhere to the safety rules and regulations in the laboratory.
- f. Before entering the lab student should ensure he/she has wore an apron, cap, mask, and carries with him/her all necessary materials required for practical like bottles, label crayons etc.





- •Students while studying in college, if found indulging in anti-national activities contrary to the provisions of acts and laws enforced by Government and any activity contrary to the rules of discipline will be liable to be expelled from the college without any notice given by principal of college.
- Ragging is prohibited by law. Any student indulging in this activity shall be dealt with as per the Rules.
- If any of the statement made in application form or any information supplied by the candidate in connection with her admission is found to be false or incorrect later on at any time, he/she may be expelled from the college by the Principal and prosecuted, if deemed necessary.

Action against ragging: Maharashtra Prohibition of Ragging Act 1999 and its amendments which may be published from time to time. The Act is in effect from 15^{th} May, 1999 has the following provisions for Action against Ragging.

- a) Ragging within or outside of any educational institution is prohibited,
- b) Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term up to 2 years and/or penalty, which may extend to ten thousand rupees.
- c) Any student convicted of an offence of ragging shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal.
- d) Whenever any student or, as the case may be the parent or guardian or a teacher of an educational institution complaints, in writing, of ragging to the head of the educational institution, the head of the educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately forward the complaint to the police station

having jurisdiction over the area in which the educational institution is situated for further action. Where, on enquiry by the head of

the educational institution, it is found that there is no substance, prima facie, in the complaint received, he/she shall intimate the

fact, in writing, to the complainant. The decision of the head of the educational institution shall be final.

e) If the Head of the educational institution fails or neglects to act in the manner specified in section "d" above when a complaint of ragging is made, such person shall be deemed to have abetted the offence and shall, on conviction, be punished as provided for in section "b" above.

Any Acts or its amendments which may be published from time to time or Judgments by Hon. Courts of India will be applicable to Candidates.


