### ACTION TAKEN-I

#### ACTION PLAN-(2022-23)

- 1. To develop additional infrastructure for Pharm. D course:**  
Two new laboratories and classrooms should be developed for Pharm. D course.
- 2. Continuation of Academic Excellence: Adherence to the following practices**
  - Curricular planning, implementation, monitoring and corrective actions.
  - Gap analysis: Content beyond syllabus to be given by each faculty member by consultation with HoD. This should be covered by subject teachers and through guest lectures/ skill development program.

  - Skill development programs on Clinical trials, Laboratory Safety, Aseptic Techniques, Calibration of Instruments and Statistical methods should be conducted.
