



FUNCTIONS:

- To prohibit and address any and all forms and instances of ragging in the college and hostel premises.
- > To educate the students on matters of ragging as a menace and the legal aspects of Antiragging act.
- To take necessary and required measures to prohibit ragging activities.
- To counsel students for prohibiting them from indulging, actively or passively in any ragging activity.
- To punish those who indulge in ragging as provided in regulations.
- To monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the Institution.
- To submit report to affiliating University on the matters pertaining to Anti-ragging Cell.

PUNISHMENTS:

Depending upon the nature and seriousness of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:-

- Suspension from attending classes and academic privileges
- Withholding/ withdrawing scholarship/ fellowship and other benefits
- Debarring from appearing in any test/ examination or other evaluation process
- Withholding results
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/ expulsion from the hostel
- Cancellation of admission
- Rustication from the institution for period ranging from 1 to 4 semesters
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period
- Fine ranging between Rupees 25,000/- and Rupees 1 lakh
- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.
