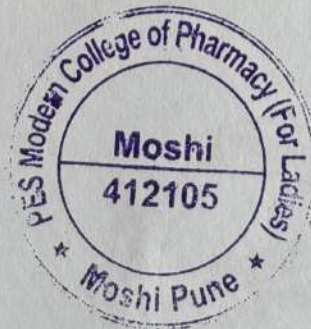



Responsibilities Anti-ragging squad

The Anti-ragging squad shall carry out the following function

- It Shall work under the overall guidences of the Anti-ragging Committee
- The Squad shall have vigil and patrolling function
- It shall be kept mobile,alert and active at all times and shall be empowered to inspect places of potential ragging and make surprise raids on hostels and other hot spots
- It will conduct regular and surprise checking at various places,hostels and classroom from time to time,and will appraise the ARC
- It shall carry out on-the-spot investigation into any incident of ragging and make recommendation to the ARC
- It shall be conduct anonymous random surveys among freshers to check whether the Campus is indeed free from ragging.
- It shall ensure the anti-ragging posters are displayed in designed places.
- It shall be occasionally dine with the newcomers in the hostels to instill confidences among them
- It shall provide a report to the AntiraggingCommitttee every day for the first month and thereafter as directed by the principal.

ANTI-RAGGING CELL Mechanism

1. To Ensure Compliances with the provision of above mentioned regulations, we act promptly with the incidences of ragging.
2. To keep continuous monitoring on the events related to ragging in campus or off-campus.
3. To be vigilant at all hours including at odd hours all round the campus and other places vulnerable to incidences of, and having the potential of, ragging and shall be empowered to inspect such places.
4. To conduct anonymous random survey among fresher to check whether the campus is indeed free from ragging.
5. To conduct on the spot enquire into any incident of ragging referred to it by the head of institution or any other member of the faculty or any other member of staff, or any parent as the case may be, and the enquiry report along with the recommendation shall be submitted to the anti-ragging cell for action under clause of regulation 9.1 of UGC.
6. To bring Sufficient awareness by displaying boards written with legal consequences and punishment under anti-ragging act. A helpline number suggested by UGC should be mentioned on the notice board to be displayed in Corridors of the college, in the front of administrative office, all class rooms, boys and girls common rooms and in front of the college.
