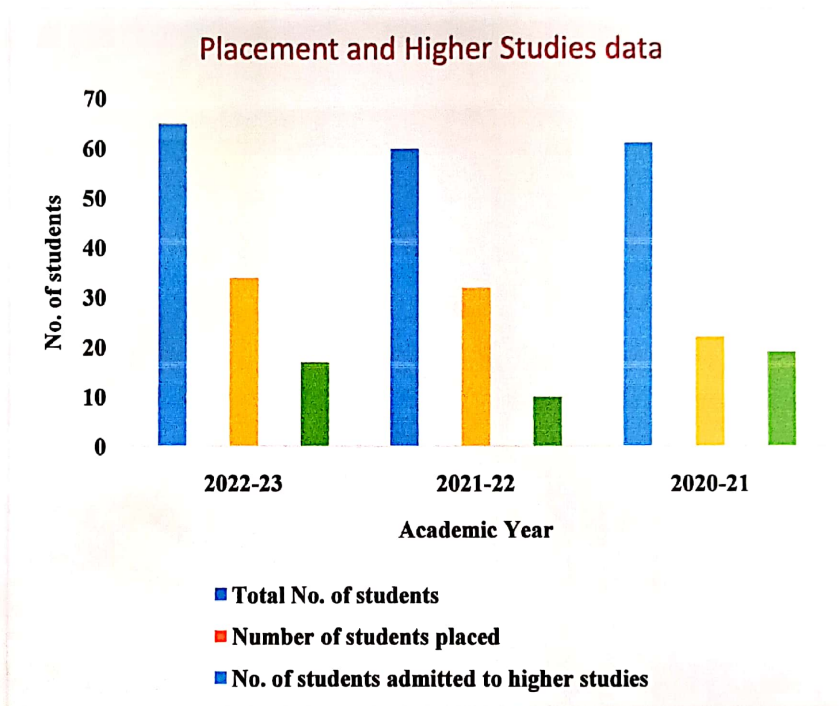

### **“Pre-Placement Training Workshop” held in Modern College of Pharmacy (for Women) Moshi**

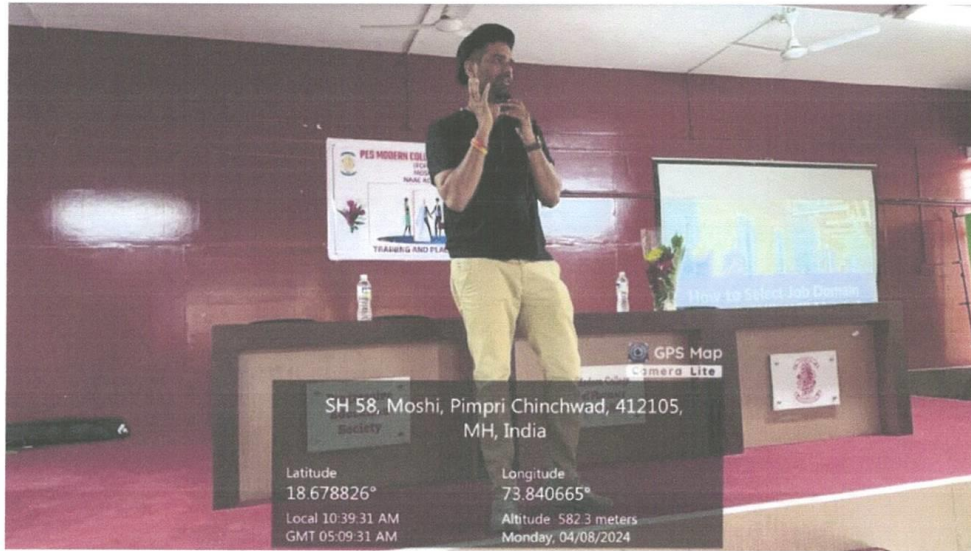

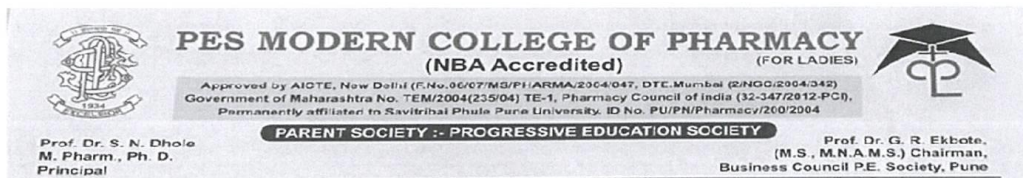

**Summary Report on Guest Lecture**  
**On**  
**“Mental Health and Suicide Prevention”**

**Date and Duration:** 31<sup>st</sup> Jan. 2024 at 12.30pm to 1.30pm.

**Resource Person:** Mr. Summon Patra, Trainer, Counselor and Coach, Bhuvaneshwar

**Objectives:**

1. To provide training to maintain mental health.
2. To create awareness about mental health and suicide prevention.
3. To understand how to deal with mental disturbance, its route of cause and how to prevent oneself from negative thinking.
4. Develop and promote the adoption of core education and training guidelines on the prevention of suicide and related behaviors by all health professions, including graduate and continuing education.

We, PES Modern College of Pharmacy, for Ladies, Moshi, organized an “Mental Health and Suicide Prevention” for the D. Pharmacy students on 31<sup>st</sup> Jan. 2024. The key speaker for this event was Mr Summon Patra, Trainer, Counselor and Coach, Bhuvaneshwar. The speaker was introduced by Ms. Iqra Choudhary, F.Y. D. Pharmacy student and felicitated by Mrs. P.D. Sonawane.

Mr Summon Patra explained that research indicates that mental health conditions such as depression, psychosis and substance use are associated with an increased risk of suicide. Experiencing risk factors doesn't necessarily mean a person will think about or attempt to take their own life. Protective factors can reduce suicide risk, particularly effective mental health care, counselling, social support and connectedness. He also discussed that Often people who are considering suicide are dealing with a combination of mental ill-health and difficult life events. Symptoms such as very low mood, negative thinking, severe anxiety, and psychosis can lead to suicidal thoughts.

He also discussed about the factors aside from mental health conditions, contributing to being at risk of suicide which may include:

- substance abuse
- chronic health issues, pain or physical disability
- feelings of isolation or helplessness
- loss
- negative life events (abuse, significant loss, financial crisis)
- previous suicide attempt or exposure to suicide behaviour in others.

He guided students for dealing with negative thinking, how to maintain mental health, how we can control our thinking and how to prevent suicide attempt through demonstration. The lecture was attended by 118 students of Diploma Pharmacy. The students were very satisfied with the lecture and they thanked the experts for their valuable guidance. Overall, the programme was a great success. Finally the vote of thank was given by Ms. Iqra Choudhary, F.Y. D. Pharmacy student.
