

Facilities For women

A. Safety and Security

- The college has constituted Anti-sexual harassment cell, Women Cell, Antiragging Cell, Internal Complaint Committee, Grievance redressed as per the Statutory Requirements. Any Gender related issues are handled by ICC within stipulated time period.
- A complaint box and suggestion box are kept in the corridor to receive complaints related to sexual harassment.
- The contact numbers of women helpline and Bhosari MIDC police station are displayed on the notice board. "Damini Pathak" is also active in the college for safety purpose.
- The college has installed CCTV facility in college campus classrooms, corridors, entrance on each floor for security purpose.
- The College has lady security guards and lady bouncers for the security purpose.
- The College has maintained in/out register for visitors.
- The College also implemented "Nirbhay Kanya Abhiyan" in association with Board of Students Development Cell of SPPU. In this activity students are made aware about Laws and Regulations. Also students are trained for self-defense.
- Students are instructed to wear uniform and I-card daily compulsory.
- Leave application and permission from class teachers for leave is mandatory for the students.
- Fire safety and fire alarm system is also installed in the college. Fire extinguishers and sand buckets are also placed throughout the campus.
- To check adequacy of security measures, Gender Audit is conducted every year.

B. Counselling

- Counselling and mentoring sessions are conducted periodically for students.
- Dr. Rajeev R. Nagarkar, Professional Counselor has been appointed for students and individual as well as group counselling sessions are arranged frequently and/or as per need.

C. Common Room

Common room is provided with facilities such as bed, personal lockers, First Aid box and medicines for basic treatment for Primary care, Tables, chairs, Sanitary napkins vending and disposal machine, dustbins, changing room with mirror.

D. Any other

Ladies hostel with all facilities and safety and security measures is well established by the college within the campus. Institution promotes the students and faculty to actively participate in various public and extracurricular activities.
